

EVENT SPECIFICATIONS

Timing: Tuesday 24th and Wednesday 25th October 2023.

Duration: 2 days.

Location: City of Zadar, Croatia.

Target audience: Eight existing and fourteen new ITI cities in Croatia (three to four people per city, plus Managing Authority (MA) staff - total participation: 150).

OVERALL OBJECTIVE

The overall objective of the event is to increase the capacity of urban authorities involved in the 22 urban ITIs in Croatia to deliver high quality Sustainable Urban Development (SUD) under EU Cohesion policy for the 2021-2027 period, in the spirit of Article 11 of the ERDF/CF Regulation 1058/2021.

SUB-OBJECTIVES

- To facilitate fruitful exchange of experience between urban authorities active in delivering ITIs in Croatia and to explore relevant good practices in ITI delivery and content from elsewhere in the EU.
- To encourage Croatian urban authorities to explore different governance arrangements for ITIs, covering multiple municipalities and organisational arrangements, for effective delivery of integrated SUD.
- To help Croatian urban authorities better understand how cross-sectoral policies can be linked through ITIs and how best to promote synergies between sectoral interventions in a practical sense.
- To stimulate innovative approaches in the context of ITI in Croatia, both in delivery models and in bringing ideas for new types of projects.

LEARNING FORMATS

The event will focus on active learning in plenary, workshop and field visit settings, including case studies bringing concrete examples for participants to learn from.
